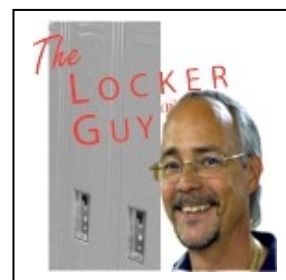
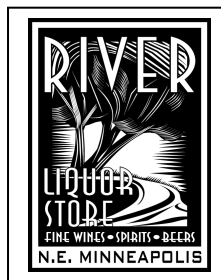

## Carl Fietek Goes “On Broadway” for 20<sup>th</sup> CBA Title at New Hope Bowl

**Carl Fietek** found the right way to play the Kegel Broadway Pattern during the match play portion of the CBA tournament averaging 238 for the 6 games after averaging 196 during qualifying to vault into the top spot heading into the stepladder. He took on Qualifying Leader **Scott Pohl** in the title match and a tough battle ensued. Fietek started with double-spares-double while Pohl had 4 out of 5 spares. Pohl had a late turkey but Fietek just needed to mark in the 10<sup>th</sup> to win and he threw it right down “Broadway” for a strike and a 203-189 victory. Fietek has tied Sam Lantto for the most wins in CBA history.

The first stepladder match had CBA president **Chad Nelson** taking on a bowler from the past who hasn’t bowled in quite a few years, **Gregg Stricke**. Stricke lived up to his name as he started the game with the front 8 and settled for a 266-229 win. He then had to face Pohl and didn’t have the same results early and Pohl put him away 237-212. Pohl then took on the defending champion **Rob Clements** in the semifinal match on a pair that was way off “Broadway” as both bowlers struggled but Pohl came away a winner 160-134.

**Scott Pohl** was the decisive Qualifying Leader with a score of 1741 (217 avg) for the 8 games of qualifying as **Dan Bock** qualified 2<sup>nd</sup> only 148 pins behind. It took a score of 1523 (190 avg) to make the top 12 cut and 1514 (189) to cash. **Tom Korth** won the Bonus Senior cash spot with 1507 (188 avg). Current CBA Iron Man **Ron Kish**, who has not missed a CBA tournament since August 2003 held off everyone in the 9<sup>th</sup> & 10<sup>th</sup> frame eliminator rolloff for the “*On Track Casher*” and a free entry into the July CBA tournament. Kish is the only bowler to win a CBA title as the “*On Track Casher*” when he won at New Hope in July 2007.

The CBA would like to thank the entire Bender family and their staff for hosting our CBA tournament.
